By-Law Number 2024-

A By-Law to Amend By-Law Number 2022-62, “Kingston Zoning By-law Number 2022-62” (Removal of Holding Overlay H186, 386 and 390 Johnson Street and 40 Aberdeen Street)

Passed: May 21, 2024

Whereas the Council of The Corporation of the City of Kingston enacted By-Law Number 2022-62, “Kingston Zoning By-law Number 2022-62” (the “Kingston Zoning By-law”); and

Whereas the property owner has submitted an application requesting the removal of the Holding Overlay from the lands municipally known as 386 and 390 Johnson Street, and 40 Aberdeen Street; and

Whereas in accordance with Section 22 of the Kingston Zoning By-law, the property owner has satisfied the conditions for the removal of Holding Overlay H186, including:

- (a) The City is satisfied that there is adequate servicing capacity (i.e., water, wastewater, natural gas, and electrical) for the proposed development; and,
- (b) A Transportation Impact Study is completed that includes micro-simulation scoped to the satisfaction of the City.

Therefore be it resolved that the Council of The Corporation of the City of Kingston hereby enacts as follows:

1. By-law Number 2022-62 of The Corporation of the City of Kingston, entitled “Kingston Zoning By-law Number 2022-62”, as amended, is further amended as follows:
 - 1.1. Schedule F is amended to remove the Holding Overlay H186 from the subject lands, as shown on Schedule “A” attached to and forming part of this By-Law.
2. This By-Law shall come into force in accordance with the provisions of the *Planning Act*.

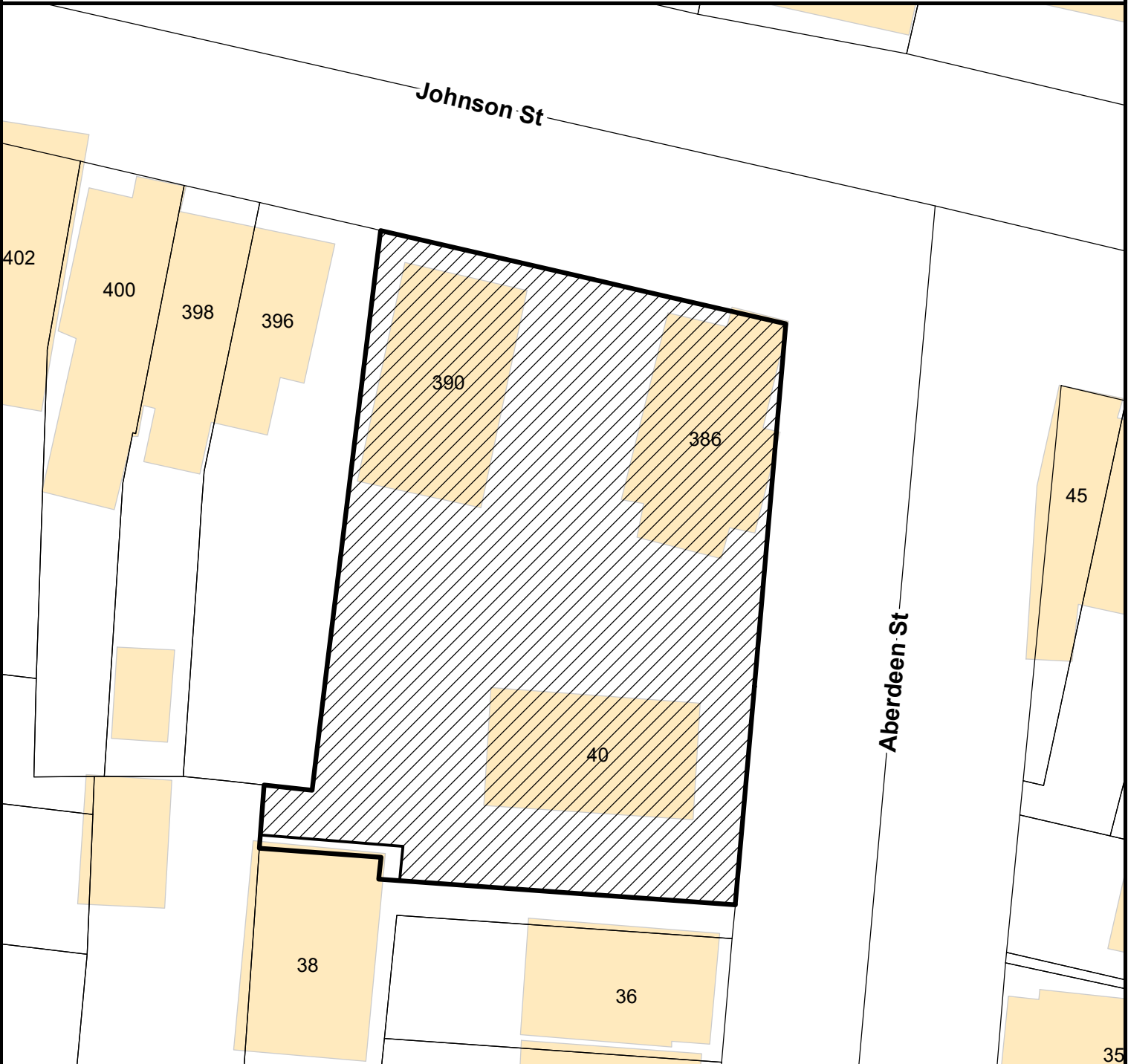

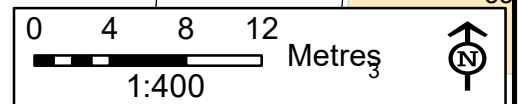
