#### **Options/Discussion:**

The City's Facilities Maintenance & Construction Services Department (FMCS) is responsible for the renovations, construction, asset & energy management, and maintenance of City owned buildings and properties. All work is planned to meet the Facilities Accessibility Design Standards (FADS) wherever feasibly possible. Below is a list of key accessibility items addressed in recently completed, current and future construction projects, as well as issues addressed during regular building maintenance and topics covered through staff training.

#### 2023/2024 Construction Projects Highlights (Completed Projects):

#### City Hall:

- Graspable handrails for main staircase
- Accessible exterior wayfinding signage
- Revised signage for restrooms to include all-gender (underway)

#### Kirkpatrick Fountain Restoration:

Widened sidewalks around the fountain as part of restoration

#### Transit Bus Shelters at Henderson Blvd:

- Turning radius within shelter
- Vision strips on glass and edges
- Tactile warning surfaces
- Bariatric seating
- Enhanced lighting

#### City Surface Parking Lots (underway):

- The project involves installing new lighting systems over the extent of multiple parking lots and associated pathways where lighting does not currently exist.
- Lighting at each site will be provided by overhead LED fixtures mounted on poles.
- If identified, accessible stalls may be moved to a more optimum location near pay devices and pathways.
- Monitoring the frequency of use of accessible stalls to see if additional stalls are needed.

 Starting design efforts to restore and reconfigure the existing stairs and landscaping at the entrance to 1211.

#### Isabel Turner:

- Full interior renovation and replacement of the HVAC systems.
- New universal washrooms.
- Lower accessible book stacks.
- Accessible checkout desk.

Transit Bus Shelters (anticipating three (3), or four (4) new locations by end of 2024):

- Turning radius within shelter.
- Vision strips on glass and edges.
- Tactile warning surfaces.
- Bariatric seating.
- Enhanced lighting.

#### **Key Maintenance Practices**

Protective scaffolding installed annually over the Market Street entrance to protect staff and visitors from falling snow and ice. This allowed the accessible entrance to remain open throughout the winter and has become part of the regular winter routine.

#### Rick Hansen Foundation Training:

FMCS staff (Lindsay Down & Cam Burns) recently completed the Rick Hansen Foundation Municipal Cohort Accelerator. This program consisted of four extensive workshops that brought together municipalities and key figures in accessibility from across Canada. The goal was to address accessibility issues and explore ways to promote, implement, and enhance accessibility in municipalities.
