# **Executive Summary:**

The *Playground Accessibility* Plan is the route by which the City can achieve Goal 3.1.2D in the Strategic Priorities for 2023-2026. This plan will review the City's 120 playgrounds and then provide strategies and recommendations for increasing accessibility via park renovations and new park development. The project began in March 2025 and will conclude in October 2025.

Supported by a consultant, the City will undertake an accessibility analysis of existing playground inventory, along with best practice research. Public and stakeholder engagement will be ongoing within this timeframe.

Deliverables include a draft plan that will be presented to Municipal Accessibility Advisory Committee (MAAC), with recommendations and implementation strategies to increase accessibility in City playgrounds. The plan will consider budget, human resources, and implementation and distribution strategies over a 10-year workplan.

To ensure the City engages a diversity of external perspectives on this topic, we request advice from MAAC on potential stakeholder groups that should be consulted as part of this project. We are also looking for suggestions from MAAC on how best to ensure the public consultation process is both accessible and inclusive.

#### **Options/Discussion:**

#### Background - Accessibility in Parks and Playgrounds

The City of Kingston recognizes the importance of both accessibility and play.

Play is not just the work of childhood; play is wellness, at all life stages. Inclusive, accessible playgrounds allow children, youth and adults of all abilities to play together, to enhance their well-being.

Within the 2023-2026 Strategic Plan, Goal 3.1, under the priority to *Build an Active and Connected Community*, is focused on expanding opportunities and participation in parks and recreation. Playground accessibility is a priority identified within part 2D of this goal, directing the development of a City-wide *Playground Accessibility Plan* that identifies existing playground inventory and a strategy to increase accessibility in playgrounds.

Increasing accessibility in City playgrounds will benefit all members of society; it ensures broad usability, fosters meaningful participation and enriches collective experience.

#### **Project Introduction**

Accessibility in parks and playgrounds is about more than meeting legal standards and removing barriers. It is about creating an inclusive and equitable environment where everyone can engage, participate and play.

The *Playground Accessibility Plan* will review in the City's 120 playgrounds and provide recommendations to increase accessibility via park renovations and new park development. The project will begin in March 2025 and end in October 2025, and comprises four (4) phases, with public and stakeholder engagement an ongoing component across the project timeline (see Project Timeline below).

#### **Project Timeline**

Phase 1: Background Research/ Best practice + Policy Context Review Timeline: Early 2025

Phase 2: Accessibility Analysis: Scoring and Ranking of Playgrounds Timeline: Spring 2025

Public + Stakeholder Consultation Sessions Timeline: Ongoing

Phase 3: Draft Recommendations and Implementation Strategies Timeline Spring – Summer 2025

Phase 4: Draft and Final Submission of Document Timeline: August – September 2025

Data gathered in Phase 1 and Phase 2 of the project will be synthesized with data derived from consultation with the public, external and internal stakeholders. Integration of these separate data sets will form the basis for Phase 3 draft recommendations and implementation strategies, which will be presented to the public in a second phase of community consultation.

Phase 4 will include the production of the final deliverables and presentation of the final *Playground Accessibility Plan* document and project recommendations to MAAC. Final recommendations and implementation strategies will consider asset replacements, budgets and fiscal constraints, human resources and capacity, and a distribution strategy within a 10-year workplan based on feedback received through consultation and data analysis.

# Public Engagement and Stakeholder Group Consultation

An extensive and ongoing campaign of community engagement is required as part of the process of developing the *Playground Accessibility Plan* with public and/or stakeholder consultation concurrent to each project phase.

Public Engagement and Stakeholder groups will allow the City to better understand needs, usage, opportunities and challenges related to current play equipment and playgrounds. It will also be instrumental in gathering data on desired future asset provision in City parks and playgrounds and strategies to prioritize investment in assets to greatest impact.

Consultation will also include internal City stakeholders to ensure project proposals and recommendations can be achieved as part of City operations and service level provision. These stakeholders are anticipated to include Recreation & Leisure Services, Engineering Services, Public Works, Transportation and Community Development, Wellbeing & IIDEA.

To ensure the City engages with a diversity of external perspectives on this topic, we request advice from MAAC on potential stakeholder groups that should be consulted as part of this project.

# Actions to Date:

In 2024, playground visits were conducted to gather photos and data related to the accessibility of each site. In the Fall of 2024, the RFP for consulting services was posted and a consultant team was hired in early 2025.

# Indigenization, Inclusion, Diversity, Equity & Accessibility (IIDEA) Considerations


